**(Second Additional Placement)**

**REGISTRATION DATES: 20 - 23 SEPTEMBER 2021**

**CANDIDATES MUST APPLY TO REGISTER IN-PERSON. APPLICATIONS FOR REGISTRATION BY MAIL WILL NOT BE ACCEPTED.**

\*All the information and documents that are to be provided in the registration must match with those submitted in the application process. Please note that any application for registration with missing or incomplete relevant documentation, or with forged information will not be accepted.

\*Registration is between 08:00 – 17:00

\*Candidates must apply in-person to the Registrar’s Office for registration.

**REQUIRED DOCUMENTATION FOR REGISTRATION**

1-Exam Result together with a copy of certified translation submitted in the application process

2- High school diploma (certified by a notary public in Turkey or Turkish Embassies) together with its certified translation.

3-Diploma Equivalence Certificate for high school credentials issued by Directorate of National Education or by Turkish Consulates/Embassies (the original).

4- A copy of the valid passport with student visa and a certified translation into Turkish (certified by a notary public in Turkey or Turkish Embassies). Students of Syrian descent have to submit a copy of the Temporary Protection Identification Document.

5- Photograph (two pieces) taken in the last 6 months to enable the applicant to be clearly recognized (size: 4.5x6cm). Scanned or photocopied photographs will not be accepted.

6-Transcript of Records (an official document issued by their high school and stating the graduation date and the CGPA).

7- A copy of TÖMER certification (if applicable)(at least B2 level).

8-Bank receipt proving the payment of registration fee.

9-Students who acquired Turkish citizenship by birth and lost Turkish citizenship by getting alienage permit issued by the Ministry of Interior Affairs must be able to prove that they have

a certificate concerning the exercise of the rights entitled by the law no. 5203 (Turkish ‘Blue Card’ or sample record to be obtained from Blue Card Registry through Identity Sharing System along with an official document showing identity information issued by the authorities of the state of citizenship.)

10-Students with dual citizenship have to submit a Certificate of Identity Register Copy (issued by Civil Registry offices in Turkey).

11- Candidates who are citizens of Turkish Republic and have completed all of their secondary education abroad must document that they have been abroad during the education period from passport or security sources in order to determine that they received their secondary education through formal education.

### **TURKISH LANGUAGE PROFICIENCY EXAM: 24 SEPTEMBER 2021**

Students who do not hold a TÖMER certificate as proof of their proficiency must take the Turkish Language Proficiency Exam organized by Osmaniye Korkut Ata University. Students who pass the Exam are enrolled into programs. Those who fail the Exam are required to enroll for a year-long Turkish language courses offered at OKÜ TÖMER.

**NOTA BENE:** Health Insurance: Once registered, students must apply for health insurance via Social Security Institution (SGK). Please note that you will be expected to submit your Foreigner Identity Number (“Yabancı Kimlik Numarası”) in the application. Please also note that students who do not apply for health insurance will not be able to avail themselves of any health care services in Turkey.
